Winnett ACES has accomplished a great deal in this short time: establishing a local beef-to-school program, hosting continuing education programs for farmers and ranchers, supporting building a community center, and funding numerous rangeland and conservation projects through-out the Musselshell Plains. In June 2019, the Winnett ACES Inc. was designated as a non-profit 501(c)3.
